August is National Immunization Awareness Month (NIAM), the annual observance spotlights the importance of vaccines for people of all ages.

Unfortunately, the COVID-19 pandemic caused many children and adults to get behind on routine vaccinations, putting them at greater risk of developing preventable diseases. Together we can create awareness to assist in getting everyone's immunizations up to date!

NDHIN serves as the message broker of immunization data for participants connected through NDHIN. This valuable information is needed to make informed decisions regarding the vaccination status of patients. NDHIN's technical team works closely with participants and their EHR vendors to establish connectivity, receiving immunization data directly from the participant's EHR. Once connectivity is established, immunization data is passed on to the North Dakota Immunization Information System (NDIIS) in real time for processing. NDHIN supports EHR queries to NDIIS to retrieve a patient's immunization history and forecast. The data that is shared is viewable in NDHIN's Clinical Portal. In addition, NDHIN monitors the connections for any issues that may arise and coordinates troubleshooting sessions with the vendors and NDIIS until resolution is achieved. Participants find connecting through NDHIN to be a benefit since their technical resources are relieved of the responsibility of monitoring and maintaining the immunization interfaces. On July 17th, the NDIIS completed a new electronic connection to the Refugee Immunization Information Systems Exchange (RIISE). Users will now see immunization records for refugees being relocated to North Dakota in the NDIIS.

Office of the National Coordinator for Health Information Technology (ONC) Is Now Administration for Strategic Preparedness and Response (ASPR).

On July 25, <u>HHS announced</u> a reorganization to streamline and bolster technology, cybersecurity, data, and AI strategy and policy functions which had historically been distributed across HHS.

As part of the reorganization, ONC has been renamed the Assistant Secretary for Technology Policy and Office of the National Coordinator for Health Information Technology and has assumed oversight over technology, data, and Al policy and strategy for the department, including the HHS-wide roles of Chief Technology Officer, Chief Data Officer, and Chief Al Officer.
