Kelli Just, President & Training Officer with Community Volunteer EMS of LaMoure shares how she finds NDHIN to be beneficial in her daily practice.



“Being able to access NDHIN quickly in an emergency setting is vital to excellent patient care when the patient is unconscious or in an alerted mental state. NDHIN allows EMS providers to access the patient’s medications, allergies, and past medical history.”

“Accessing NDHIN following a 911 call to read the outcome of the patient has been extremely beneficial in training. During run reviews at our squad trainings, we are able to review the care that was provided and then once we read the outcome, we can critique the care provided and prepare ourselves for similar calls going forward.”

“There have been many times when we take a patient to a critical access hospital and the doctor is unable to access the patient’s medical records because their system is not compatible with their primary provider. If the provider would instead log into NDHIN, then they would be able to see the completed healthcare record.”

A benefit to accessing the comprehensive database is that it can help identify potential risks or complications during anesthesia, allowing CRNAs to take necessary precautions to ensure patient safety.

- **Care coordination:**

The use of NDHIN supports better communication between all patient's healthcare providers, including CRNAs, which is essential for coordinated patient care, especially during transitions between care settings.
